New Hampshire National Guard Scholarship Program

1. **REFERENCE:** RSA 110-B:60-63, as amended, (1985) is the State law which governs the fund to provide educational benefits for all members of the New Hampshire National Guard (Air and Army). All armory rental fees from sources other than governmental agencies are credited to the Scholarship Fund by the State Treasurer. A committee of five persons will oversee the fund.

2. **ELIGIBILITY:** No award to any person shall exceed \$500 per fiscal year. To be eligible, an applicant must:

- a. Be a member in good standing of the New Hampshire National Guard.
- b. Must apply for assistance to pay tuition only.
- c. The institution, school, college, university, etc., must be one of higher learning or postsecondary education located within the State of New Hampshire.
- d. The applicant must either be a student or desire to be a student at the institution, but need not be a full-time student nor is there a restriction as to courses of study, subject matter, or degree requirement.

3. **ADMINISTRATION:** The scholarship committee shall make the final determination of scholarship recipients in any fiscal year. Repeat awards are permitted, but no award shall exceed \$500 for each fiscal year for any one person. Awards shall be made annually between June 30 and September 1; but no award may be paid out prior July 1 of the current year. Payment will be made directly to the academic institution unless the committee determines otherwise. Any unused portion of approved scholarships is returned to the general Scholarship Fund and becomes available for new applications in the next fiscal year.

4. **CHANGE OF STATUS:** It is the responsibility of the unit commander to notify the Adjutant General's Office when a change of status, affecting eligibility, occurs prior to course commencement.

5. **APPLICATION:** Applicants must complete TAGNH Form 14 and file it with TAGNH, ATTN: Scholarship Committee, on or before June 1 of any year to be eligible for an award in the upcoming fiscal year, beginning July 1. Notification of the amount of the award will be provided to the institution by the applicant.
